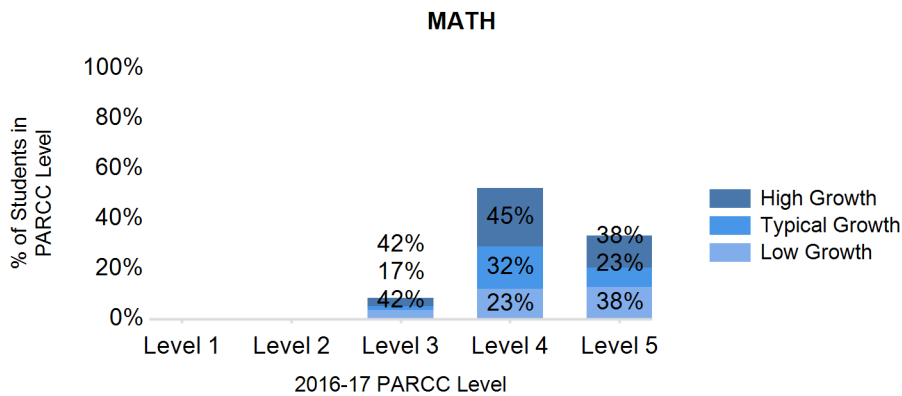
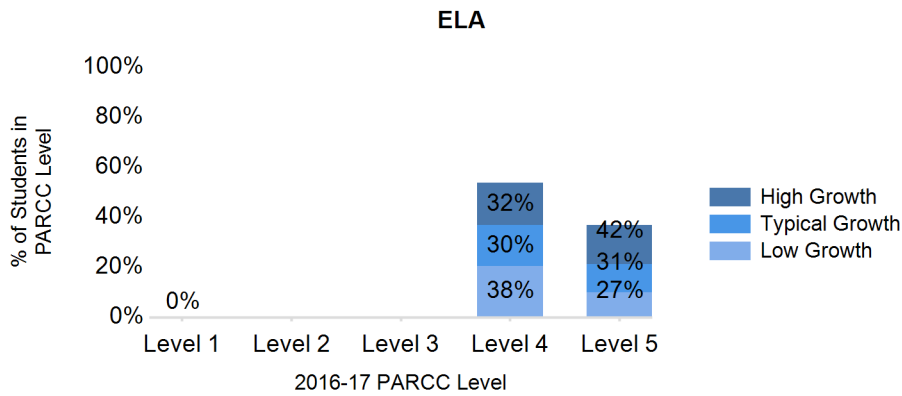

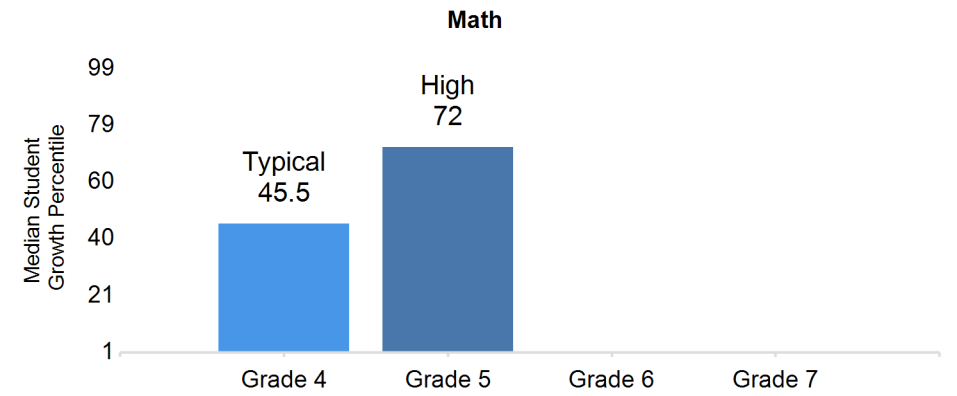
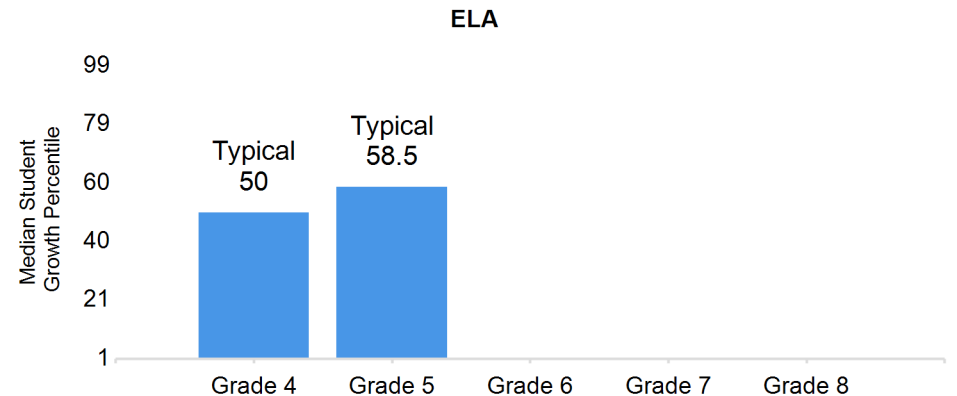
Student Growth by Performance Level

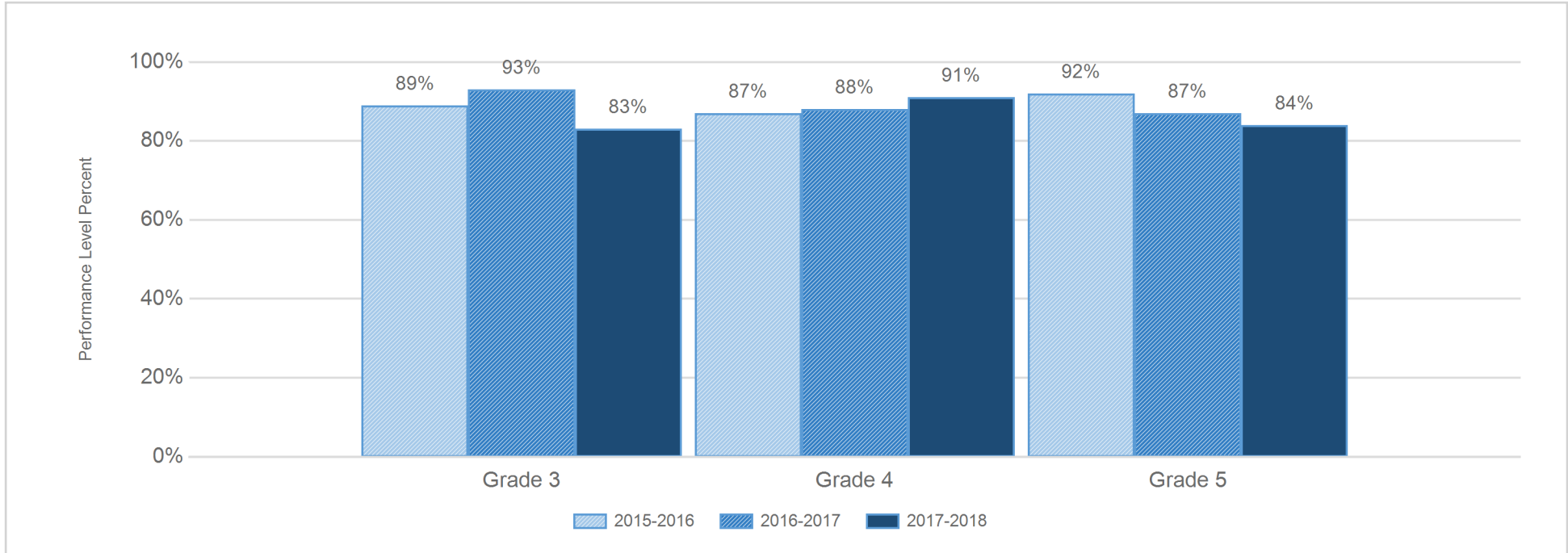

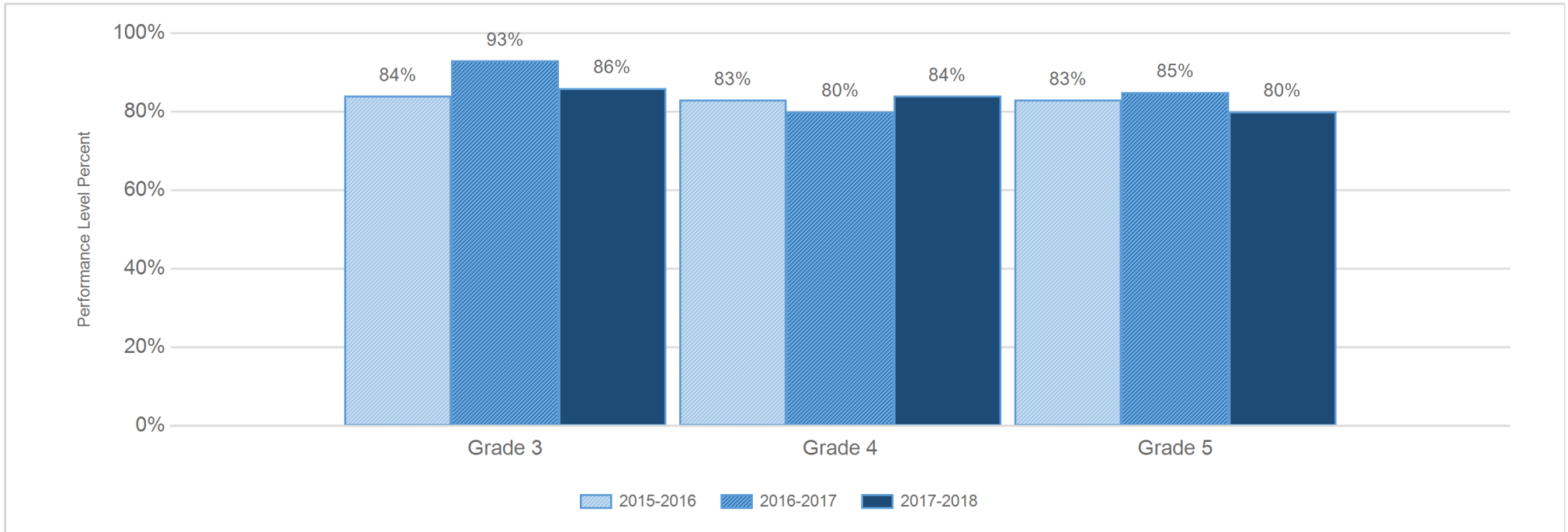

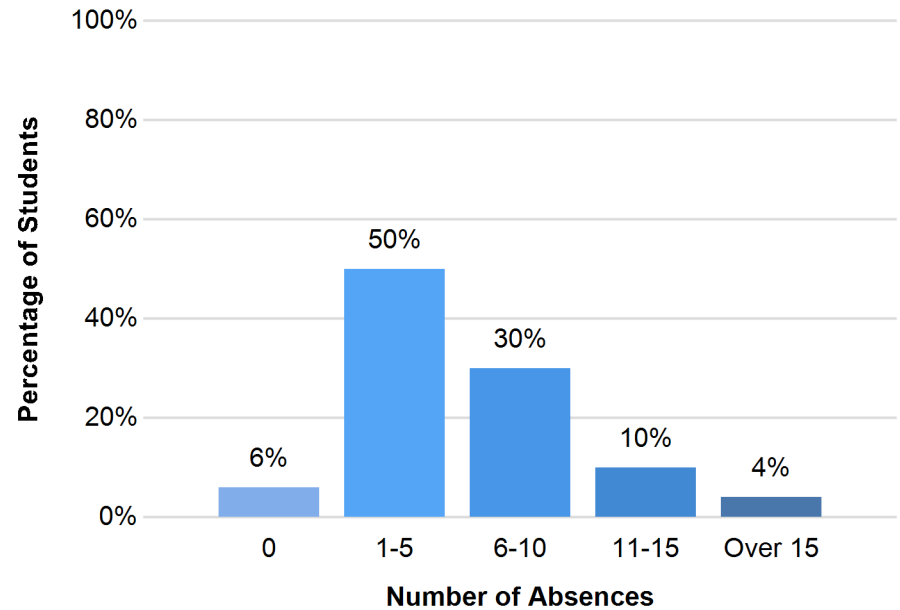

This graph shows the percentage of K-12 students by the number of days they were absent during the school year.





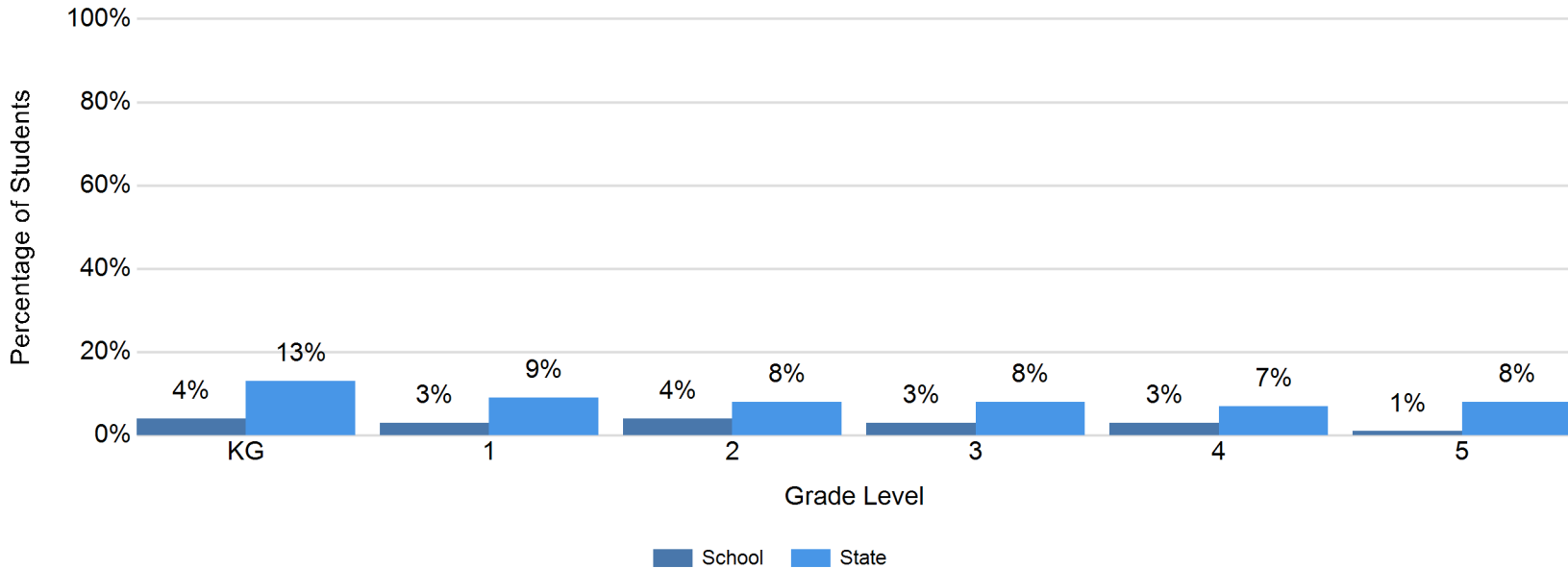

Other Information:

Hawes Elementary School is a caring learning community with a population of approximately 421 students in grades kindergarten through five. Visitors immediately sense the warmth and spirit of cooperation present at Hawes. Parents and teachers work together to provide an academically challenging curriculum and culturally rich environment for our children. Recognizing that the ability to read and write is the foundation for success in all academic disciplines, developing a literate student body is a primary focus of the educational program and staff development initiatives. Teachers collaborate with one another to differentiate language arts instruction using the workshop model. Using literature and informational texts as guides, students learn the skills necessary to become truly literate readers and writers. Children publish personal narratives, memoirs, essays, realistic fiction, and informational pieces. The elementary mathematics program combines the practice of foundational skills with problem solving. Our goal is for the students to apply their knowledge of mathematics to life situations in an accurate, efficient, and thoughtful manner. Enrichment activities, as well as support programs, provide the children with an exemplary experience in mathematics. An inquiry-based science program gives our students opportunities to make predictions, collect data, take notes, graph information, reach conclusions, and create hypotheses. Hands-on experiences with earth, environmental, life, and physical science materials allow students to develop both process and thinking skills and apply them in making decisions and solving real-world problems. The study of communities, cultures, and history is the basis of our social studies program. Grade level teams implement units of study designed to allow children to experience the traditions of others and life in the past. Infused in all lessons is the importance of showing respect to individuals and groups.
